

TERMS AND CONDITIONS – CLIMATE FINANCE INDIA PRIVATE LIMITED (CFIPL)

Notice

Please read these terms and conditions carefully. These terms and conditions (“**Terms**”) form a legally binding agreement between you, the user (“**you**” / “**User**”), and Climate Finance India Private Limited (“**CFIPL**” / “**Company**”), governing your access to and use of this website and any pages of this website (the “**Website**”).
